Filing deadline is April 19, 2022 at 4 p.m. with the Township Clerk. Candidates may circulate Nominating Petitions and gather between 3 -10 signatures if running as a Republican or Democrat, or between 9 – 30 signatures as a No Party Affiliation candidate on a Qualifying Petition. In lieu of circulating petitions, candidates may pay a \$100 non-refundable filing fee.

Candidates must also file an Affidavit of Identity and a Statement of Organization at the time of filing.
