

The exact wording, numbered #6 which was submitted on November 1, 2021, is as follows and is deemed to not be of sufficient clarity:

**On July 5, 2021 Jed Welder attended a Sidney Township board meeting as a township trustee. At this board meeting, Mr. Welder cast the lone vote against adopting the Sidney Township Wind Energy Ordinance (No. 2021.01). Mr. Welder did not abstain from voting although he had previously signed an easement agreement with Coral Wind I LLC, or also known as APEX. This agreement hopes to develop wind turbines on Mr. Welder's property and would financially benefit Mr. Welder.**

The exact wording, numbered #5 which was submitted on November 1, 2021, is as follows and is deemed to not be of sufficient clarity:


