THE PRESIDENTIAL PRIMARY ELECTION IS FOR THE PURPOSE OF PLACING IN NOMINATION BY THE POLITICAL PARTIES PARTICIPATING, (Republican and Democratic) CANDIDATES FOR THE FOLLOWING PARTISAN OFFICE:

#### **PRESIDENT OF THE UNITED STATES**

**PLEASE TAKE NOTICE that the following proposals will appear on the ballot in all Montcalm County precincts:**

##### **Library Millage Proposal**

Shall the tax limitation on all taxable property in the County of Montcalm be increased and the County be authorized to levy a millage in the amount of .90 mill (\$.90 on each \$1,000.00 of taxable value) for a period of ten (10) years, 2020 to 2029 inclusive, of which .50 mill is a renewal of the millage rate that expires in 2019 and .40 mill is new additional millage, for the purpose of providing funds for library services to the people of Montcalm County and for all library purposes authorized by law, the proceeds of which will be distributed to the Carson City Public Library, Flat River Community Library, Home Township Library, Reynolds Township Library, Richland Township Library, Tamarack District Library, and the White Pine District Library? The estimate of the revenue the County will collect if the millage is approved and levied in the first (2020) year is approximately \$1,714,000. By law, revenue from this millage may be subject to capture by the Montcalm County Brownfield Redevelopment Authority.

##### **LAW ENFORCEMENT MILLAGE PROPOSAL**

Shall the tax rate limitation on all taxable property within the County of Montcalm, Michigan, be increased and the County be authorized to levy a new additional millage in the amount not to exceed 1 mill (\$1.00 on each \$1,000 of taxable value) for five (5) years, 2020 to 2024, inclusive, for the sole purpose of funding Law Enforcement functions, providing personnel and equipment, conducting road patrol, and any other public safety purpose authorized by law?

The estimate of the revenue collected if the millage is approved and levied by the County in the first year of the levy (2020) is approximately \$1,904,216.47. To the extent required by law, a portion of this millage may be captured and retained by the Village of Edmore Downtown Development Authority, the Crystal Township Downtown Development Authority, the Village of Howard City Downtown Development Authority, the Village of Lakeview Downtown Development Authority, and the City of Greenville Downtown Development Authority.

**And in Sidney Township ONLY the following proposal:**

**PROPOSAL TO SET THE NUMBER OF STATE LICENSED MARIJUANA ESTABLISHMENTS  
ALLOWED WITHIN ITS BOUNDARIES**

Shall Sidney Township, pursuant to the Michigan Regulation and Taxation of Marijuana Act, set the number of state licensed marijuana establishments allowed within its boundaries, as follows?

- Class A Grower, up to two (2)
- Class B Grower, up to two (2)
- Class C Grower, up to two (2)
- Marijuana Microbusiness, no limit
- Marijuana Processor, zero (0)
- Marijuana Retailer, zero (0)
- Secure Transporter, zero (0)
- Safety Compliance Facility, zero (0)

**And in Gratiot-Isabella Regional Education Service District ONLY the following proposal:**
