Proposal 20-1

A proposed constitutional amendment to allow money from oil and gas mining on state-owned lands to continue to be collected in state funds for land protection and creation and maintenance of parks, nature areas, and public recreation facilities; and to describe how money in those state funds can be spent.

This proposed constitutional amendment would:

- Allow the State Parks Endowment Fund to continue receiving money from sales of oil and gas from state-owned lands to improve, maintain and purchase land for State parks, and for Fund administration, until its balance reaches \$800,000,000.
- Require subsequent oil and gas revenue from state-owned lands to go into the Natural Resources Trust Fund.
- Require at least 20% of Endowment Fund annual spending go toward State park improvement.
- Require at least 25% of Trust Fund annual spending go toward parks and public recreation areas and at least 25% toward land conservation.

Should this proposal be adopted?

Proposal 20-2

A proposed constitutional amendment to require a search warrant in order to access a person's electronic data or electronic communications.

This proposed constitutional amendment would:

- Prohibit unreasonable searches or seizures of a person's electronic data and electronic communications.
- Require a search warrant to access a person's electronic data or electronic communications, under the same conditions currently required for the government to obtain a search warrant to search a person's house or seize a person's things.

Should this proposal be adopted?

VILLAGE OF PIERSON PROPOSAL

Village of Pierson New Additional Millage Proposal

Shall the Village of Pierson's voted allocated millage rate of 12.5 mills (\$12.50 per \$1,000 of taxable value), now reduced to 10.1595 mills (\$10.1595 per \$1,000 of taxable value) by the required Headlee millage reductions, be increased by 1.8405 mills (\$1.8405 per \$1,000 of taxable value) up to 12.0 mills (\$12.00 per \$1,000 of taxable value), to restore a portion of the millage rate lost by the required millage rollbacks, and shall the Village of Pierson levy such additional allocated millage of 1.8405 mills (\$1.8405 per \$1,000 of taxable value) for twenty (20) years, 2021 through 2040 inclusive, to provide funds for general operating and all other Village purposes, thereby raising an estimated \$3,875 in the first year of its levy.

Shall the limitation on the amount of taxes which may be assessed against all property, except principal residence and other property exempted by law, in Alma Public Schools, Gratiot, Montcalm and Isabella Counties, Michigan, be increased by 1 mill (\$1.00 on each \$1,000 of taxable valuation) for a period of 14 years, 2021 to 2034, inclusive, to provide funds for operating purposes; the estimate of the revenue the school district will collect if the millage is approved and .063 mill is levied in 2021 is approximately \$8,300 (this millage is to restore millage lost as a result of the reduction required by the Michigan Constitution of 1963 and will be levied only to the extent necessary to restore that reduction

TRI COUNTY AREA SCHOOLS PROPOSAL

Tri County Area Schools Operating Millage Proposal

This proposal will allow the school district to continue to levy the statutory rate of not to exceed 18 mills on all property, except principal residence and other property exempted by law, required for the school district to receive its full revenue per pupil foundation allowance and restores millage lost as a result of the reduction required by the Michigan Constitution of 1963.

Shall the currently authorized millage rate limitation on the amount of taxes which may be assessed against all property, except principal residence and other property exempted by law, in Tri County Area Schools, Montcalm, Kent and Newaygo Counties, Michigan, be renewed by 17.9244 mills (\$17.9244 on each \$1,000 of taxable valuation) for a period of 2 years, 2021 and 2022, and also be increased by .0756 mill (\$0.0756 on each \$1,000 of taxable valuation) for a period of 2 years, 2021 and 2022, to provide funds for operating purposes; the estimate of the revenue the school district will collect if the millage is approved and 18 mills are levied in 2021 is approximately \$2,317,000 (this is a renewal of millage that will expire with the 2020 levy and a restoration of millage lost as a result of the reduction required by the "Headlee" amendment to the Michigan Constitution of 1963)?

To provide funds for Mid Michigan College, Michigan, shall the limitation on the amount of taxes which may be assessed against all property in the proposed annexed territory of Gratiot-Isabella Regional Education Service District, Michigan, be increased in perpetuity by 1.2232 mills (\$1.2232 on each \$1,000 of taxable valuation), representing the community college district charter millage; the estimate of the revenue the community college district will collect within the annexed territory of the intermediate school district if the millage is approved and levied in 2020 is approximately \$3,110,000?
