2021 Draft Assessment

Joel would like to lower the assessment to \$20.00 for a factor of 1 in order to spend down some of the balance. Todd advised that they are holding a significant balance and it would be safe to lower the special assessment.

A motion was made by Todd and seconded by Joel to roll the special assessment back to \$3,100.00 for next season. Motion carried

Weed Program Update


Mike joined the meeting via phone and advised that there have been two treatments since the last meeting in June. The first treatment, on June 29, treated 1 acre in the pothole. The second treatment, on August 30, treated just under 7 acres throughout the lake. Mike advised that the board has spent \$16,258.00 in 2021 including application fees. He advised the board that they can expect a price increase from \$800 to \$875 for application fees, as well as an increase in chemical pricing. Most chemicals will be seeing a 6%

increase, while a few will see an increase of 16-18%. Mike and Jennifer both advise holding a fund balance of \$30,000 to allow for carryover and provide a contingency.

#### Financial Update

Todd provided a financial update and advised that they are holding a large balance and could safely lower the assessment for next season.

There being no further business to come before the Lake Board, a motion was made by Todd and seconded by Joel to adjourn the meeting at 4:05 p.m. Motion carried.
