PUBLIC COMMENTS

Dennis asked a question regarding the excessive number of geese and the amount of goose excrement. Inquired about a spray program to deter the geese. Todd advised that the geese are not really a part of the Lake Improvement Board's prevue, and he should contact the MSU Agricultural Department.

OLD BUSINESS

Chara Removal

Ken mentioned that Lou, a property owner, was concerned that his lot was not being treated with the rest of the lake. Ken advised that the treatments were more of a spot


treatment, and not of the entire lake. He also advised Lou to contact Mike at ~~Progressive~~ RLS if he would like some additional treatments applied directly to his property.

NEW BUSINESS.

Treatment Plan

Mike advised that there had been two treatments done on the lake to date. The first was started on 5/19 for the canal, the outlet, and the pothole. Treatment was stopped and postponed because it was too wet outside. That treatment was completed on 5/26 for 14.5 acres of milfoil. He advised that a mixture of Percellacore and Diquat was used for treatment at that time. There is still some heavy growth at the outlet. Mike also updated the board that the E-coli testing shows that there has been very little transfer of plants and E-coli from Lake Stanton into Dickerson.

There being no further business to come before the Lake Board, a motion was made by Todd and seconded by Joel to adjourn the meeting at 4:27 p.m. Motion carried.
