##### Weed Control Program

See treatment Journal. Rick provided an update on the lake. He said that it is likely there will be no more surveys this season. He advised that more Procellacore was used this year and it produced great results and he is expecting similar results next season. Harvey asked Rick's opinion on dumping Rainbow Lake water into Muskellunge once the drain is completed. Rick said that the water quality will change, but water is flowing a long way and growing through a lot of natural waterways before getting to Muskellunge and

EGLE would not have approved that route and course if it was unsafe for Muskellunge Lake. Rick stated that the contract with the service provider is on going and there is no need for approval.

#### Board Vacancy

Sandy Tiffany was suggested by the Lake Association to fill the vacancy on the board. Harvey has spoken with her, and she is interested in the seat. Todd advised that we will need a letter from the township showing their support for Tiffany. Tiffany will need to submit a letter of interest to Maple Valley Township first.


#### Financial Update

Bob agreed with Todd and Rick advised that chemical prices may go up and there should be a bit of contingency money in the budget for that. Bob and Harvey both agreed to keep the tax roll as is for now.



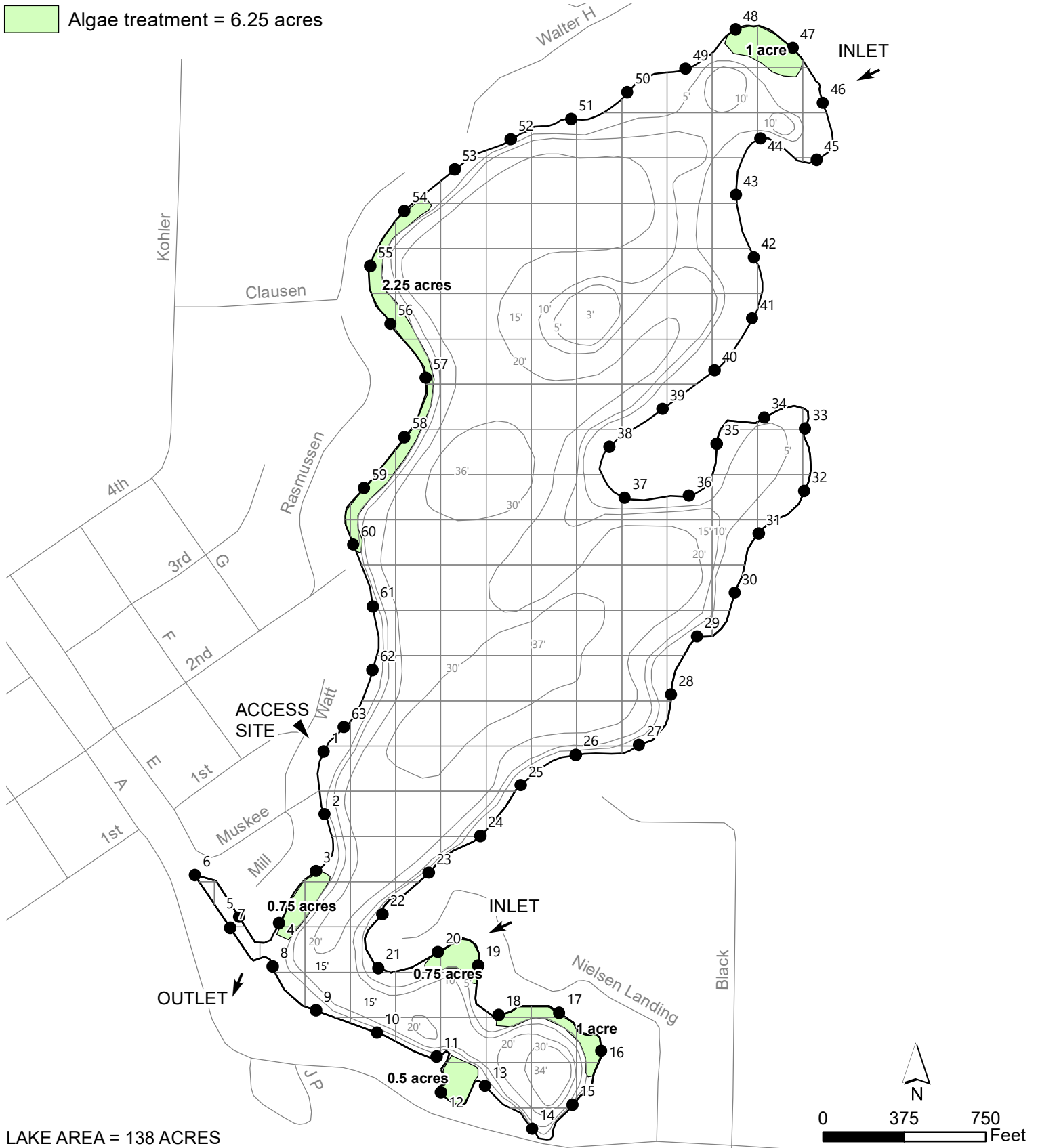
