WEED CONTROL PLANS FOR 2022

David provided a presentation of the weed control plan for this year which included:

1. A review of this years budget.

2. Scheduled Water Quality Measurements:

- a. **SPRING WATER QUALITY SAMPLING:** Week of 4/11/2022
- b. **FALL WATER QUALITY SAMPLING:** Week of 8/29/2022
- c. **Inlet will be sampled Week of 4/11, and Week of 8/29**
- d. **ECOLI TESTING (Post Treatment/Pre-Harvest):** Week of 6/20/2022

3. Weed Surveys:

- a. **PRE-TREATMENT VEGETATION SURVEY:** Week of 5/16/2022
- b. **POST TREATMENT/PRE-HARVEST SURVEY:** Week of 6/20/2022
- c. **FULL "AVAS" SURVEY:** Week of 8/8/2022

4. Herbicide Treatments:

5-12	Algae, Milfoil, Curly-leaf pondweed, Chara	Cutrine plus Navigate, Diquat dibromide, Endothall
6-9**	Algae, Milfoil, Curly-leaf Pondweed, Starry Stonewort	Cutrine plus, Diquat dibromide, Aquathol K, Endothall
6-30	Algae, Starry Stonewort, Mixed pondweeds	Cutrine plus, Diquat dibromide, Endothall
7-14	Algae, Starry Stonewort, Pondweeds	Copper sulfate, Cutrine plus, Diquat dibromide, Endothall
8-18	Starry stonewort, Algae	Copper Sulfate, Cutrine plus, Endothall
9-8	Water lilies, Emergents	Glyphosate, Imazapyr

(Also included is the treatment of a limited area for native weeds)

5. Limited Weed Harvesting:

- a. **FOR 2022 WE HAVE CONTRACTED FOR "AS NEEDED" WEED HARVESTING IN SELECTED AREAS**
- b. **HARVESTING IS TENTATIVELY SCHEDULED FOR LATE JUNE/EARLY JULY (Pending growing conditions)**
- c. **SECOND HARVEST IN LATE AUGUST IF NEEDED**
- d. **TOTAL AREA TO BE LIMITED TO 20 TO 30 ACRES**

LAKE TREATMENT NOTICE

David indicated that this years Weed Treatment Notice will be mailed out within the next couple of weeks.

SURVEY RESULTS

David reported on the results of the Lake Survey which was mailed out to each property owner in the Duck Lake Special Assessment District. The survey requested a yes or no support for doubling of the current assessment for weed control. 184 letters were sent out, with 65 being returned. 41 of the returns indicated a yes, while 24 indicated a no.

The public was allowed time to address the Board.
