Old Business

Update Weed Control Program

Rick presented a work journal for 2020. Four surveys were done and treatments for algae, wild celery and nuisance natives. New regulations only permit treating within 100 feet from the shoreline. Algae is bad but treating this time of year is not worth the cost. A spring

treatment can be done. Wild celery and eel grass are the biggest problem; harvesting is not an efficient way to get rid of them.

A motion was made by Jerry and seconded by Todd to approve extending the contract with MLS for weed treatment for next season. Motion carried.

Goose Control Update

Goose roundup was not done this year as the program was canceled because of the covid pandemic. The geese were not a big problem this year.

New Business

Confirm 2020 Assessment Roll

There were no corrections for the assessment roll. Board agreed that the full amount of the budget should be spread on the 2020 tax roll.

Other Business

Gary informed the board that he is resigning his position. He will send a letter of resignation to the township and recommend that they appoint Victor Matulis to fill the vacant seat. Gary has been a great asset to the board and he will be greatly missed.


There being no further business to come before the Lake Board, a motion was made by Todd and seconded by Jerry to adjourn the meeting at 5:22 p.m. Motion carried.
