LAKE IMPROVEMENT BOARD MEETING

June 27, 2023

A meeting of the Rainbow and Middle Lakes, Lake Improvement Board was held at the Montcalm County Drain Commission, 211 W. Main Street, Stanton, Michigan on the 27th day of June 2023 at 9:00 A.M.

The meeting was called to order by Doug at 10:00 a.m.

A motion was made by Bill and seconded by Todd to approve the agenda. Motion carried.

A motion was made by Bill and seconded by Don to approve the minutes from June 27, 2023, as presented. Motion carried.

Public Comment

No public comment.

Treatment Update

Doug provided an update from Mark. Mark said that the lake looks great. He has some ProCellacore left over from another project and used it to spot treat milfoil in a problem area. Don mentioned that there is a spot of heavy chara that is difficult to navigate. Todd noted that Rainbow & Middle Lakes are having the best treatment results this season.

Financial Update

Todd provided a financial update to the Board including a current balance of \$34,988.32, which is around one year’s assessment. Doug asked if the current balance indicates that they should forecast a 10% increase. Todd said that wouldn’t be a terrible idea and would allow for price increases.

Public Hearing

Todd provided and updated assessment roll and map to the Board. The Board discussed parcel # 016-019-015-32 and determined that parcel should be listed as direct and should be changed to a factor 1. Todd explained that the DNR parcel was set at a factor of 0, as

there is currently no mechanism for the LIBs to charge the State of Michigan. Todd advised that with the proposed roll, a factor of 1 would be charged \$187.80 and a factor of .50 would be charged \$93.90 with a total budget of \$38,500.00 per year. Todd added that the Drain Office will draft a letter to include with the mailing notice to give a brief overview of the proposed changes to the residents.

A motion was made by Don and seconded by Bill to remove the contiguous lot factor and accept the updated roll and assessment and approve a yearly budget of \$38,500.00.

Motion Carried.

Other Business

Todd asked the Board about the water level and was advised that the level is down since the installation of the Rainbow Lake Drain. Todd is going to follow up with Dan Main regarding the assessment.

There being no further business to come before the Lake Board, a motion was made by Bill and seconded by Don to adjourn the meeting at 9:54 a.m. Motion carried.

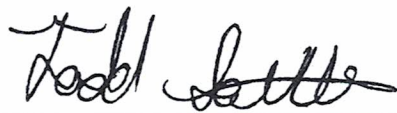
