There are many pikes in the fish that could cause issues with stocking as they could eat everything. Tom sked Mike for recommendations for other fisheries to reach out to. Mike suggested another fishery. Anne is to find contact information.

Treatment Plan

Mike advised that the lake is scheduled for the first treatment on May 22nd. He is still deciding what he is going to use for the initial treatment on the season.


Financial Update
