June 12, 2023

A meeting of the Muskellunge Lake, Lake Improvement Board was held at the Montcalm County Drain Commission, 211 W. Main Street, Stanton, Michigan on the 12th day of June 2023 at 3:00 P.M.

The meeting was called to order by Bob at 3:05 p.m.

A motion was made by Todd and seconded by Pat to approve the agenda as presented. Motion carried.

Public Comment

Treatment Update

Rick provided a treatment map and journal. 11 acres were treated with Diquat, 3.25 acres were treated with Procellacor & Diquat, and 1.5 acres received Clipper treatment. He noted that some additional milfoil treatments will be necessary, as well as some touch-ups needed after the last treatment. Rick noted that there are clumps of purple loosestrife along the shorelines, but it is difficult to treat if its not an in-lake plant. If it is on the shoreline, they may need to get residential permission and still may not be able to treat based on the exact location. Pat asked if a land applicator can treat the purple loosestrife with dry roots. Todd said that is a bit of a gray area and it would be best to only treat if PLM can complete the treatments. Sandy would be happy to speak with residents if treatment is permitted. Sandy noted that wild celery is growing and Rick responded that they are unable to treat that under the permits.


Financial Update

Todd said Randy is welcome to attend the next meeting to express his interest, but he would also like to allow the opportunity to residents that may not have been present at the association meeting. Todd asked the Board to spread the word of the vacancy and invite all interested parties to the next meeting. The next meeting will be held on Thursday, September 14, 2023, at 3:00 pm.

There being no further business to come before the Lake Board, a motion was made by Todd and seconded by Sandy to adjourn the meeting at 3:41 p.m. Motion carried.
