LAKE IMPROVEMENT BOARD MEETING

May 18, 2023

A meeting of the Winfield Lake, Lake Improvement Board was held at the Montcalm County Drain Commission, 211 W. Main Street, Stanton, Michigan on the 18th day of May 2023 at 4:00 P.M.

The meeting was called to order by Denise at 4:02 p.m.

Financial Update

Todd presented a financial update to the board, including the current balance of \$33,965.07.

A motion was made by Tom and seconded by Todd to accept the financial summary as presented. Motion carried.

Treatment Update


Rick advised that he had completed a survey of the lake earlier in the day and noted a lot of growth of the thin leaf pond weed, which is native and the curly leaf pond weed, which is invasive and can be treated. Rick recommends an early harvest for the thin leaf pond weed since it cannot be chemically treating. Rick will get PLM out there for the harvest for \$425.00 an acre. He is expecting 10-12 acres to be harvested. Dick is going to check with the farmer to the west to make sure it is still okay to dump the spoils in his field. Rick also noted that there is a little bit of milfoil growing with the thin leaf and that the milfoil, thin leaf, and curly leaf will all come out with the harvesting. Harvesting is generally done in the fall, but at this point it is necessary to do it now to make the lake

navigable. He also noted that some of the thin leaf is too close to the shore to be harvested and may need a permit variance to treat it chemically.

Other Business

Todd asked about the current lake level. Tom and Denise said the level is average. Denise added that the Lake Association has agreed to pay for new contour mapping of the lake. The next meeting will be held on September 14, 2023, at 4:00 pm, in the Drain Office.

There being no further business to come before the Lake Board, a motion was made by Todd and seconded by Tom to adjourn the meeting at 4:30 p.m. Motion carried.


