

**LITTLE BASS LAKE
LAKE IMPROVEMENT BOARD
HEARING OF PRACTICABILITY & REVIEW OF APPORTIONMENTS
July 11, 2023**

A special meeting of the Little Bass Lake, Lake Improvement Board was held in the Belvidere Township Hall, 107 Vesta St., Six Lakes, Michigan on the 11th day of July 2023, at 6:00 p.m.

The hearing of practicability was called to order by Joan at 6:00 p.m.

Chairman Rusieki introduces the lake board members.

A motion was made by Margaret and seconded by Todd to approve the minutes of the June 5, 2023; meeting as presented. Motion carried.

Todd explained the procedures of the Hearing of Practicability and the Review of Apportionments and the necessity of both hearings.

Joan advised the residents that the Board had met with a possible new applicator and took a trip around the lake with him to discuss the problem areas. They addressed their concerns regarding the current applicator and the treatment of the lake. After the meeting with Mark from Clearwater, they are leaning towards working with him as a new applicator for next season.

The chairman opened the meeting up to the public for questions and comments.

Sandra Gomes asked how the new applicator would affect pricing and treatment costs. Joan responded that they believe the new applicator will be a lower cost and will provide better communication and treatment. Sandra asked if they could try the new applicator for one year to gauge results before signing an extended contract. Joan advised that Mark offers different contract terms for 1, 3 or 5 years. The most cost efficient is the 5-year contract but they are willing to sign a 1-year contract to see how the lake improves. Sandra asked about the fish

stocking program since they haven't stocked fish in the last five years. Joan noted that the Board has been working with a couple of hatcheries to decide what type of fish would best suit the lake with the current habitats since they are currently unable to get the Red Eared Sunfish. Todd added that hatcheries are struggling to provide the right types of fish to lakes all over Michigan. Sandra asked if they are going to continue to set aside money each year for fish stocking since they are already holding a significant balance. The Board would like to table the fish stocking funds for now until they can find the right fish for the lake. Bruce Zimmerman noted that he fishes a lot and doesn't see anything wrong with the lake. Sandra added that some of the lake is so bad with weeds that she has to cut her trolling motor and get back with an oar and also noted that the lily pads are bad. Todd explained the difference between native and invasive weeds and how the state has regulations on treatment. Sandra added that she pulls and burns the Chara. Todd added that he believes a new applicator will really help alleviate some of the concerns on the lake. Joan added again that they have already brought many of their concerns up to Mark from Clearwater.

There being no further questions or comments from the public, the Hearing of Practicability was closed by the chairperson.

The Resolution to Proceed with Improvements was offered for approval to the Lake Board.



Aquatic Herbicide Treatment (includes permit fee)	\$6,735.00

The amount of herbicide use in any given year will depend on the type and distribution of plants in Little Bass Lake and Department of Environmental Quality permit conditions. Plant control activities are proposed to be coordinated under the direction of the lake board's environmental consultant. The consultant would be responsible for preparing bid documents or contract extensions for the plant control program, assisting the lake board with the selection of the plant control contractors, and performing follow-up inspections to ensure work is performed in a satisfactory manner. The consultant would report to the lake board regarding the performance of the plant control contractors and would make recommendations to the lake board regarding payments to the contractors.

Project administration will include all costs related to meetings, postage, copies, mailings, notices, Drain Commission administration, and legal proceedings. In accordance with Part 309 of the Natural Resources and Environmental Protection Act, Act 451 of 1994, a lake board may add not let than 10% or more than 15% of the total project cost for contingent expenses.

ASSESSMENT BENEFIT FACTORS

The special Assessment District for Little Bass Lake includes all properties which border the lake and back lots which have deeded or dedicated lake access. Special assessments for the project are to be apportioned in the following manner:

The hearing for the review of apportionments was called to order by Chairman Rusieki at 6:18 p.m.

Presentation of Special Assessment Roll

Todd presented the tax roll and explained the benefit factor used to determine the amount to assess each parcel. He provided a current fund balance of \$21,723.24 and advised that it is about 3 years' worth of funds and suggested a maximum of assessment of \$7,835.00 for the 5-year cycle, but only assess out \$5,000.00 for the 2024 season.

A motion was made Todd and seconded by Mary Anne that the 2024 assessment should be set at \$5,000.00. Motion carried.

Chairman Rusieki opened the hearing up for questions and comments from the public.

No public comments regarding the Special Assessment Roll.

There being no further questions or comments from the public on the Review of Apportionments, the hearing was closed by the chairperson.

WHEREAS, the Little Bass Lake, Lake Improvement Board, after due and legal notice, has reviewed the Special Assessment Roll prepared for the purpose of assessing the cost of certain lake improvements to Little Bass Lake against benefitting properties; and

WHEREAS, the Little Bass Lake, Lake Improvement Board deems said Special Assessment Roll to be fair and equitable;

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

1. Said Special Assessment Roll in the amount of \$39,175.00 is hereby confirmed.
2. The assessments in said Special Assessment Roll shall be payable in 5 equal annual installments of \$7,835.00 with the first installment to be due on December 1, 2023, and payable without penalty through February 14, 2024. Subsequent installments shall be due on or before the 1st day of the same month of each year thereafter and are payable without penalty through the 14th day of the same month of each year thereafter.
3. The assessments made in said Special Assessment Roll are hereby ordered and directed to be collected, and the Clerk of Belvidere Township shall deliver said Special Assessment Roll to the Township Treasurer, with his/her warrant attached, commanding the treasurer to collect the assessments therein in accordance with the directions of the Lake Board, and the treasurer is directed to collect the amounts assessed as the same become due.
