

**WINFIELD LAKE
LAKE IMPROVEMENT BOARD MEETING
September 14, 2023**

A meeting of the Winfield Lake, Lake Improvement Board was held at the Montcalm County Drain Commission, 211 W. Main Street, Stanton, Michigan on the 14th day of September 2023 at 4:00 P.M.

The meeting was called to order by Denise at 4:05 p.m.

A motion was made by Todd and seconded by Tom to approve the agenda. Motion carried.

A motion was made by Todd and seconded by Dick to approve the minutes from May 18, 2022, as presented. Motion carried.

Public Comments

Janice Jourdan asked if there was a way to direct people to the website for information since all meeting information is posted there. Denise said that she is going to put an update up on the Facebook page.

Financial Update

Todd provided a financial update to the Board, including a current balance of \$20,838.00. He noted the lake is waiting on the 4th quarter consultant fee.

A motion was made by Todd and seconded by Dick to receive and file the Treasurer's report as presented. Motion carried.

Treatment Update

Rick provided a treatment journal and update. He noted that the lake was harvested in May and that the harvesting went well. After this harvest, Rick recommends harvesting a larger area and possibly completing a second harvest in future years. He noted a lot of growth near the inlet where they can't harvest too closely. Tom added that PLM did a great job with cleanup near his house. Denise did not think that the weeds came back as densely as they were before. Janice asked about the harvest and if they had a contract. She asked if they could charge less or shift the harvesting area. Rick stated that he wants to increase the harvesting area next season. Greg asked why they didn't go back to the inlet after the chemical treatment. Rick noted that PLM was told not to go all the way into

the inlet because it is native and invasive species mixed and they are regulated on treating native species.

Inlet and Outlet Discussion

Denise asked who is responsible for the care? Todd stated that the legal lake level is handled through the Drain Office and is monitored. He added that residents with issues regarding the lake level and beavers should call the Drain Office. Denise asked if the weeds on the inlet are too dense to allow water in to maintain the lake level. Rick said that it's a balancing act and that the plants in the inlet absorb a lot of the nutrients coming into the lake. Todd added that the lake association does not want to spend the money to correct the lake level.


Special Assessment

Todd presented a special assessment roll to the Board. The Board saw no necessary changes and wishes to assess the same \$32,300.00 that was assessed in 2022.

Other Business

Rick provided an update on the depth mapping. He noted that the data is processed and almost ready for review by the Board. Denise added that the residents are excited to see the mapping.

There being no further business to come before the Lake Board, a motion was made by Todd and seconded by Tom to adjourn the meeting at 4:57 p.m. Motion carried.
