

## WINFIELD LAKE

### LAKE IMPROVEMENT BOARD MEETING

May 16, 2024

---

A meeting of the Winfield Lake, Lake Improvement Board was held at the Montcalm County Drain Commission, 211 W. Main Street, Stanton, Michigan on the 16<sup>th</sup> day of May 2024 at 4:00 P.M.

The meeting was called to order by Denise at 4:09 p.m.

A motion was made by Todd and seconded by Dick to approve the agenda. Motion carried.

A motion was made by Todd and seconded by Dick to approve the minutes from September 14, 2023, as amended. Motion carried.

#### Election of Officers

Denise advised that Tom has recently had a stroke and she is unsure if he intends to keep his position on the LIB as the Winfield Township Representative. Todd advised that if Tom decides not to continue with the LIB, we will need a letter of resignation from him. The next step after that would be to have the Winfield Township Board appoint a resident to the LIB as the township representative.

A motion was made by Todd and seconded by Dick to maintain the current elected positions on the Board. Motion carried.

#### Public Comments

Cal Tryon advised that he was originally charged for his contiguous lot, but it was corrected, and he has been refunded. He asked why more improvements and treatments haven’t been done to the lake. Janice Jourdan asked why the fund balance wasn’t spent down to zero. Many residents believe that the weeds are because of chemical run off from Sandy Land farms. Cal asked why the weeds are getting worse. Todd and Rick advised that the warm winter and lack of ice is causing weeds to grow more on every lake. It was not cold enough for long enough to help discourage weed growth. Rick noted that the entire budget will be spent this season.

## Financial Update

Todd provided a financial update to the Board, including a current balance of \$46,723.64. He noted that the account has earned roughly \$400.00 in interest since the October meeting and the 2023 Special Assessment was received on 5/13. Todd asked Rick if he expects to be over budget for treatment this season. Rick anticipates spending the full treatment budget by July.

## Treatment Update

Rick and Luke provided a treatment update to the Board and advised that the budget will be spent in full this season. He repeated Todd's sentiments that a warm winter and lake of ice on the lakes has caused the huge boom in growth. Denise asked about Milfoil treatment. Rick advised that Milfoil is the first to be able to harvest and he is intending to use a faster acting herbicide. Milfoil is all over the lake and there couldn't be anymore coverage. Luke thinks they should treat and then harvest because the milfoil is very dense. Todd asked about a sonar treatment Rick said that this is a hybridized milfoil that is resistant to sonar treatments. Todd is concerned that if they harvest now, then treat, the lake will be terrible for the 4<sup>th</sup> of July. Rick noted that he would be more comfortable treating first, then harvesting. He believes that will give the lake the best opportunity to treat and clear the lake for the 4<sup>th</sup> of July. Luke is going to return on Monday to complete a milfoil targeted survey for treatment. He then plans to have the lake harvested within two weeks of the treatment. Rick provided an FAQ sheet to the residents. Denise asked for a map to show where they can treat and where they can't to provide to residents for understanding. Rick advised that he cannot treat the native weeds in the inlets. They can treat 100 ft from the shoreline or at least 5 feet of depth for native plants. Only invasive weeds can be treated in undeveloped areas. Having no weeds in the lake would cause algae to take over.

## Other Business

The Board would like to hold an additional meeting this season to approve budget overages. The next meeting will be held on June 11, at 2:00 and Luke will complete a survey the same day, as long as the weather allows. Dick noted that he rode alone for the harvest last year and told the harvesters that boats tend to take a certain path around the lake and assumed that harvester would follow the same path.

There being no further business to come before the Lake Board, a motion was made by Todd and seconded by Dick to adjourn the meeting at 5:03 p.m. Motion carried.
