A meeting of the Dickerson Lake, Lake Improvement Board was held at the Montcalm County Drain Commission, 211 W. Main Street, Stanton, Michigan on the 9th day of May 2024 at 3:30 P.M.

The meeting was called to order by Ken at 3:34 p.m.

A motion was made by Joel and seconded by Todd to approve the agenda as presented. Motion carried.

**Election of Officers**

A motion was made by Todd and seconded by Joel to maintain the current elected positions. Motion carried.

**Public Comment**

No public comment given.

**Treatment Update**

Mike advised that they completed a survey on 5/6 and provided a treatment map. He noted that there are about 15 acres that currently need to be treated for a cost of \$14,180.00. Treatment is scheduled for 5/15 but is weather dependent. Mike noted that there is a significant problem in the channel. He also noted that they found quite a few dead blue gills during the survey, but that may be due to early spawning and temperature fluctuations. Mike advised that the warm weather will likely cause increased growth in weeds this season. Mike noted that they were not able to survey the pothole due to water levels but will bring out the air boat to complete it. Joel said he would really like it surveyed and treated if needed.

A motion was made by Todd and seconded by Joel for RLS to treat the necessary 15 acres as noted in the Survey map. Motion carried.

### Financial Update

Todd provided a financial update to the board, including the current balance of \$47,927.66. He noted that the current total in legal fees spent by the Board is \$2,459.00, which is just under the approved amount of \$2,500.00. The remainder of the legal fees will be discussed at the next meeting after the case has been heard in court.

### Special Assessment Dispute

Todd provided an update on the dispute noting that there really is no update as the hearing will be held on June 11 in St. John. The hearing has been delayed due to scheduling with the courts and requests to change the type of hearing from Zoom to In Person. Todd added that we have provided our supporting documents, as has Mr. Smith.

### Other Business

Joel asked about an update on the Sewer. Ken advised that the potential sewer system is not related to the LIB and the meeting would need to adjourn before it can be discussed.

There being no further business to come before the Lake Board, a motion was made by Todd and seconded by Joel to adjourn the meeting at 3:52 p.m. Motion carried.
