LAKE IMPROVEMENT BOARD
MEETING
May 2, 2024

A meeting of the Turk Lake, Lake Improvement Board was held at the Montcalm County Drain Commission, 211 W. Main Street, Stanton, Michigan on the 2nd day of May 2024 at 4:00 P.M.

The meeting was called to order by Todd M. at 4:00 p.m.

A motion was made by Greg and seconded by Tom to approve the agenda. Motion carried.

A motion was made by Tom and seconded by Greg to approve the minutes from October 5, 2023, as presented. Motion carried.

Election of Officers

Todd M asked if there were any changes that needed to be made to the elected positions on the Board. The Board was happy with things as they are.

A motion was made by Greg and seconded by Tom to keep the elected positions the same for the 2024 season. Motion carried.

Public Comment

Paul noted that the lake looks very clear, but there is something growing on the bottom of the lake at the southern tip of the back lake. Mike stated that he will take a look during the survey. Greg added that the lily pad treatment worked great and was timed perfectly. Paul asked if lily pads are good cover for fish. Mike and Greg said yes. Paul asked if there are any small mouth bass in the lake. Greg said no, only large mouth.

Treatment Update

Mike advised that the first survey is scheduled for May 8 and treatment should be completed about a week later. Last year, they treated 7 acres during the first treatment.

Mike noted that Hydrilla has been located somewhat locally and the state is working on a treatment plan. The state is complete sonar treatment and excavate ponds. Traditional treatment has included repeated sonar treatments. Mike asked how the Board would like to move forward with treatment approval. The Board discussed having Todd M approve treatments.

A motion was made by Greg and seconded by Tom to allow the chairperson to approve treatments as recommended by RLS. Motion Carried.

Financial Update

Anne provided a financial update to the Board, including a current balance of \$58,865.62 in the regular ledger and \$2,500.00 in the fish stocking ledger. Anne noted that the account has accrued approximately \$1,400.00 in interest payments since the last meeting in October.


Fish Stocking

Todd M advised that they had ordered 5–7-inch perch to stock the lake, but the delivery truck was in an accident while enroute, so they will have to wait until the fall to stock the lake again. Todd M is to provide the updated permit to Anne in the Drain Office. Greg is personally funding the stocking for 6–8-inch large mouth bass, around 63 fish. They talked to the DNR and learned that they are approved to stock the lake with Walleye in 2025 if they would like. Mike said to make sure that the walleye would encourage the structure of the lake. Todd M asked if a fish survey would be beneficial and if the Board could cover the cost. Mike noted that the a survey is not necessary if the fish are healthy and the terms of the resolution for fish stocking only covers the purchase of the fish.

Other Business

Tom noted that there is a pipe on the NW corner of the front lake that is always flowing. He is concerned that it may be a sewage pipe that is draining nutrients into the lake.

There being no further business to come before the Lake Board, a motion was made by Todd M and seconded by Greg to adjourn the meeting at 4:27 p.m. Motion carried.
