

**PERCH LAKE

HEARING OF PRACTICABILITY & REVIEW OF APPORTIONMENTS  
August 1, 2024**

A special meeting of the Perch Lake, Lake Improvement Board was held in the Montcalm Township Hall, 1880 S Greenville Rd., Greenville, Michigan on the 1st day of August 2024, at 7:00 p.m.

The hearing of practicability was called to order by Jack Hendricks at 7:00 p.m.

Jack introduces the lake board members.

A motion was made by Pat and seconded by Steve to accept the agenda as presented.

A motion was made by Pat and seconded by Steve to accept the minutes of the July 8, 2024; meeting as presented. Motion carried.

Todd explained the procedures of the Hearing of Practicability and the Review of Apportionments and the necessity of both hearings.

**Treasurer's Report**

Todd provided a financial update to the board, including a current balance of \$23,835.02.

**Presentation**

Rick presented the budget and weed control program to the Board and the public. He provided a budget of \$17,250.00 for 2024 – 2028. He noted that \$10,000 is for plant control, \$6,000 is for program management, and \$1,250 is for administration and contingency. Rick explained the treatments and mechanical harvesting. He noted what types of weeds are found on the lake and the chemicals that are being used to treat the weeds.

### Resident Letters

A letter was received from Connie Geer, resident, prior to the public hearing. Connie stated that her concerns had already been addressed and her letter did not need to be read at the hearing.

The chairman opened the meeting up to the public for questions and comments.

### Public Comment

Tim Hemmes asked why they are spending money on the lakes when all residents don't live on the lake. He believes the lake should be natural.

Todd explained that everyone included in the assessment district has deeded access to the lake, whether they choose to use it or not.

Tim Hemmes asked why they are not working on the roads.

Todd explained that this Board only handles weed control on the lake and cannot fix the roads.

Frank Oxford noted that the chemicals that are being used are regulated through EGLE and are not poisoning the lake.

Chuck Rau stated that treatment notices were not posted at the boat launch and nonresidents are using the lake.

Rick said they will post a notice at the boat launch to ensure that nonresidents using the lake are aware of treatments.

Pat added that the treatment is an herbicide, not a poison.

Rick added that the EPA does not require people to stay out of the water after treatments for their safety. The notices are to give the chemicals time to work before they are dispersed by use. He also added that they generally schedule treatments during the week to minimize interference from boats.

Mike Ingram advised that the Township wants to put dry hydrants in the lake.

Kim Cairns asked why Perch Lake's rate for harvesting is so much lower than other lakes.

Rick advised that the size of the lake makes it easier and less expensive for the contractors.

Jack added that LakePro also saves money on chemicals by using generic chemicals.

Kristine Cousineau asked about dredging.

Todd explained the procedures being dredging.

Rick added that EGLE has very tight restrictions on dredging permits and noted that channels have to be almost completely unnavigable before it will be allowed.

Several residents commented that the lake looks beautiful.

There being no further questions or comments from the public, the Hearing of Practicability was closed by the chairman.

The Resolution to Proceed with Improvements was offered for approval to the Lake Board.



The Special Assessment District for Perch Lake includes all properties which border the lake and back lots which have been deeded or dedicated lake access. Special assessments for the project are proposed to be apportioned in the following manner:

**USE FACTORS**

• Direct access	1.0
• Indirect access	.35

Contiguous lots in common ownership will each be assessed as a separate lot based on the above factors.

The hearing for the review of apportionments was called to order by Chairman Hendricks.

Presentation of Special Assessment Roll

Todd presented the tax roll and explained the benefit factor used to determine the amount to assess each parcel.

Chairman Hendricks opened the hearing up for questions and comments from the public.

Public Comment

Mike Ingram asked why certain parcels are included in the assessment district when it does not touch the lake.

Todd advised that all of the parcels included in the assessment district have deeded access to the lake, either through their plat or through direct access.

Tracey Brown noted that the Johansen's used an easement to let their cows go down to the lake for water and residents voted to maintain the easement.

Candy Campbell noted that her parcels are not big enough to build on. And that the state has interest in her parcels so she cannot combine them.

Todd advised that she will need to work with her assessor to correct that issue.

Pamela Strecker asked how long it will take for a combination to go into effect.

Todd advised that combinations completed by 12/1 will take effect on tax rolls starting in summer 2025.

Linda Herald asked about water quality and if septic or sewer systems are leeching into the lake.

Todd advised that they are not currently testing the water quality, but the condition of the lake indicates that there are no issues.

Paul Strecker asked if combined parcels can be re-split.

Todd advised that they can be re-split within the platted area.

Tim Hemmes stated that his lots are already not contiguous.

Todd stated that he has been assessed historically for any noncontiguous lots, so this will not likely change much for him.

There being no further questions or comments from the public on the Review of Apportionments, the hearing was closed by Jack.

The Resolution Confirming the Special Assessment Roll was offered for approval by the Lake Board.

WHEREAS, the Lake Board, after due and legal notice, has reviewed the Special Assessment Roll prepared for the purpose of assessing the cost of certain lake improvements to Perch Lake against benefitting properties; and

WHEREAS, the Lake Board has adopted the benefit factor formula as described in the attached Exhibit A.

WHEREAS, the Lake Board deems said Special Assessment Roll to be fair and equitable;

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

1. The Special Assessment Roll shall be designated as Perch Lake Special Assessment Roll. (2024 - 2028)
2. Said Special Assessment Roll in the amount of \$86,250.00 is hereby confirmed.
3. The assessments in said Special Assessment Roll shall be payable in 5 annual installments with the first installment of \$17,250.00 to be due on December 1, 2023, and payable without penalty through February 14, 2024. Subsequent installments of \$17,250.00 shall be due on or before the 1<sup>st</sup> day of the December of each year thereafter and are payable without penalty through the 14<sup>th</sup> day of the February of each year thereafter.
4. The assessments made in said Special Assessment Roll are hereby ordered and directed to be collected, and the Township Clerk of Montcalm Township shall deliver said Special Assessment Roll to the Township Treasurer, with his/her warrant attached, commanding the treasurer to collect the assessments therein in accordance with the directions of the Lake Board, and the treasurer is directed to collect the amounts assessed as the same become due.






