Treatment Update

Rick provided a treatment update to the board, including a map of the areas that were treated on May 29. He noted that the next survey is scheduled for June 25 and treatment will be completed after the 4th of July unless there is a huge bloom in the meantime. Rick added that there will likely be more total growth this year since there was such a mild winter and very little ice. Bob asked about the use of aquacide pellets to treat the purple loosestrife that they are unable to spray. Anne asked if that could be covered by the LIB. Rick said no, that would need to be handled by the lake association. Rick advised that he will reach out to the applicator for more information.


Financial Update

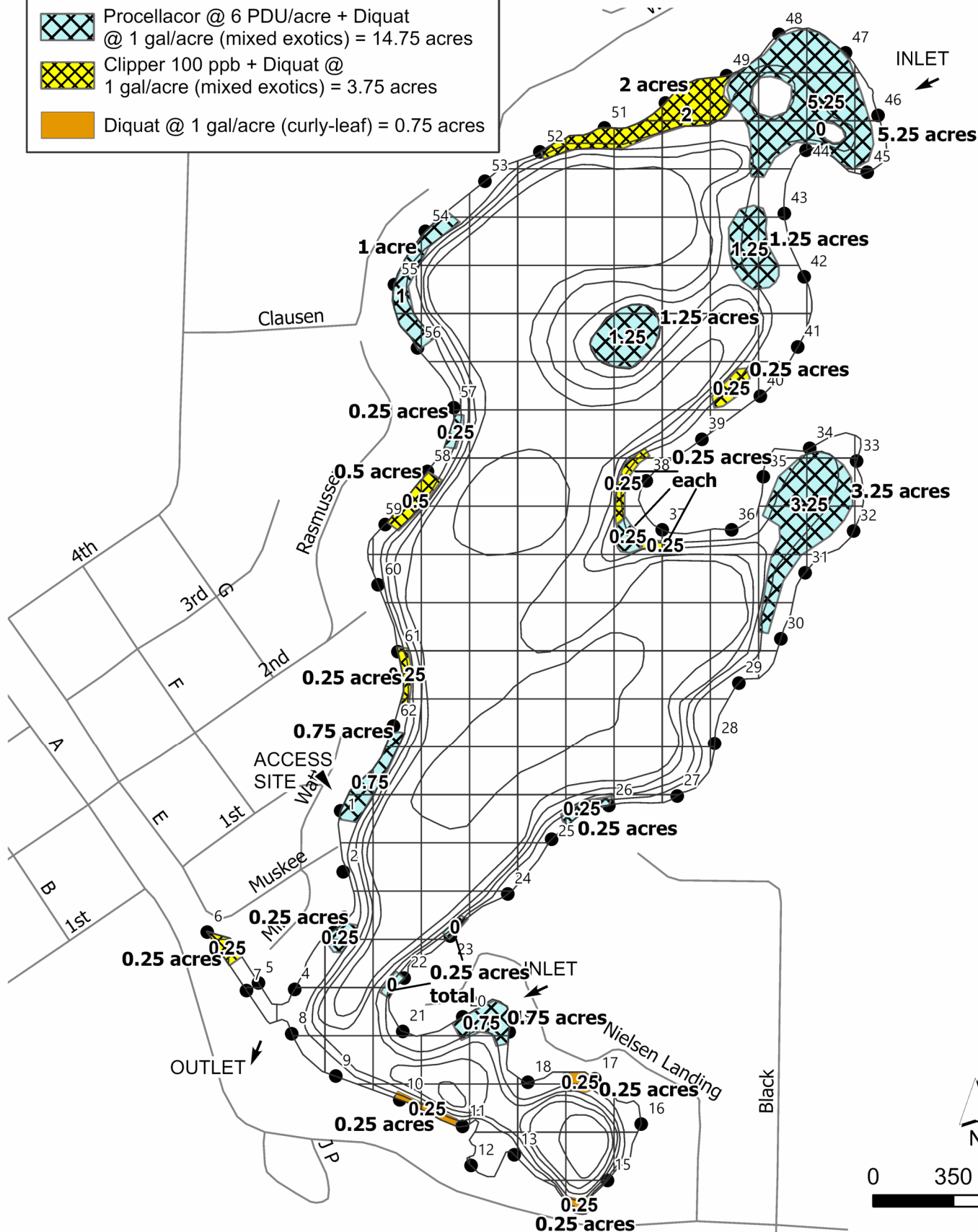

-  Procellacor @ 6 PDU/acre + Diquat
@ 1 gal/acre (mixed exotics) = 14.75 acres
-  Clipper 100 ppb + Diquat @
1 gal/acre (mixed exotics) = 3.75 acres
-  Diquat @ 1 gal/acre (curly-leaf) = 0.75 acres
