A meeting of the Turk Lake, Lake Improvement Board was held at the Montcalm County Drain Commission, 211 W. Main Street, Stanton, Michigan on the 1st day of August 2024 at 4:00 P.M.

The meeting was called to order by Todd M at 4:03 p.m.

Public Comment

Chuck Rau asked what type of fish were stocked last year. Todd M noted they were hybrid blue gill. People are very happy with the fish in the lake. Kevin asked about the pipe that was draining water from the last meeting. Greg said he has not gotten together with Tom yet to locate the pipe. Once he finds it, they intend to test the water. Chuck noted a green carpet like growth on the south end of the lake. Mike said he will have PLM look and treat if necessary. Greg asked for updates on the beavers since the lake is so low. There are no beavers, they are just experiencing low water levels.

Treatment Update

Todd M noted that the lily pads have been minimal this season. Todd M asked about a Hydrilla update. Mike said there is no update. He noted that the lake is scheduled to be treated next week, and he will have PLM look at Chuck’s property. Todd M asked about treating starry stonewort. Mike said they cannot treat it due to location. The board would like to assess the same \$34,000 for next season’s treatment.

Financial Update

Anne provided a treatment update to the board.

Fish Stocking

Todd M noted that fish stocking is scheduled for early October.

Other Business

The Board would like the water pipe to be added to the next agenda. The next meeting will be held on 10/3/24 at 4:00 pm.

There being no further business to come before the Lake Board, a motion was made by Greg and seconded by Todd to adjourn the meeting at 4:27 p.m. Motion carried.
