The last day for receiving registrations by mail, or at the County Clerk's Office, will be **Monday, April 21, 2025**.

THE FOLLOWING PROPOSALS CAN BE FOUND ON THE SPECIAL ELECTION BALLOT

In Ferris Township only the following proposals:

Fire Millage Proposal

Shall the expired tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution in Ferris Township, of 1 mill (\$1.00 per \$1,000.00 of taxable value) be renewed at the original 1 mill (\$1.00 per \$1,000.00 of taxable value) and levied for 5 years, 2027-2031, inclusive, for general fire department operation, raising an estimated \$ 52,179.00 in the first year the millage is levied?

Road Millage Proposal

Shall the expired tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution in Ferris Township, of 1 mill (\$1.00 per \$1,000.00 of taxable value) and levied for 5 years, 2027 - 2031, inclusive, for general road maintenance and repairs, raising an estimated \$ 52,179.00 in the first year the millage is levied?

And in Montcalm Township only the following proposal:

Road Millage Proposal

Shall Montcalm Township increase the tax rate limitation imposed under Article IX, Section 6 of the Michigan Constitution on general ad valorem taxes and levy a new additional millage in an amount not to exceed 0.50 mills (\$0.50 per \$1,000 of taxable value) on taxable property within the Township for five (5) years, 2025 through 2029, inclusive, and shall the Township levy such new additional millage annually on all taxable property within the Township to provide funds for the repair, maintenance, and construction of roads within the Township thereby raising an estimated \$69,504 in the first year of the levy?

All or a portion of the revenues from this millage will be disbursed to the Montcalm County Road Commission or other governmental agency for road construction, improvement, and maintenance within Montcalm Township.
