September 12, 2024**

A meeting of the Winfield Lake, Lake Improvement Board was held at the Montcalm County Drain Commission, 211 W. Main Street, Stanton, Michigan on the 12<sup>th</sup> day of September 2024 at 2:00 P.M.

The meeting was called to order by Denise at 2:03 p.m.

A motion was made by Todd and seconded by Pat to approve the agenda. Motion carried.

A motion was made by Todd and seconded by Pat to approve the minutes from June 11, 2024, as presented. Motion carried.

Public Comments

Cal Tryon noted that he called the road commission about the drain on Masters Rd. He said the drain has a void and is not flowing. Todd will touch base with Ryan and noted that the Road Commission will take care of it. Cal stated that he thinks the inlet is plugged. Todd added that it may not be flowing because it is so dry and there might just not be enough water upstream. Janice asked if there is a set time in between surveys of the lake. Luke said yes because different chemicals take different amounts of time to work. Cal asked if they expect to harvest yearly. Luke said yes.

Treatment Update

Luke provided a treatment update to the board, see attached journal. He noted considerable milfoil growth this year. He noted that starry stonewort has been found in the lake and that they treated .5 acres. He advised that there is no chemical that can completely get rid of the starry stonewort, they can only try to maintain and minimize growth. Luke advised of a possible treatment to bind phosphorus and keep algae blooms down. He added that this will not kill weeds or help with sediment immediately. He advised that it is around \$500 an acre (around 7k annually). Rick has used this on other lakes and seen a reduction in algae blooms. Greg asked if algae can be harvested. Luke said no, it can only be treated. Todd asked when this treatment would be completed. Luke stated that he would potentially like to try in April if the board was to decide to move forward. Luke noted that there is a balance of around \$1,700 left in the treatment budget for the season.



Financial Update

Todd provided a financial update to the board, including a current balance of \$25,424.73.

Other Business

Denise provided a resignation letter from Tom Kok to the board. The Winfield Township Board has been asked to add the appointment of Daniel Scheppers as the Winfield Township Representative to their next board meeting agenda. Janice is concerned that Daniel is not a full-time resident of the lake. Denise added that they do not have to be a full time resident to be concerned about the health of the lake. Todd provided a special assessment roll to the board. The next meeting will be held on May 15, 2025, at 2:00 pm in the Drain Office.

There being no further business to come before the Lake Board, a motion was made by Todd and seconded by Pat to adjourn the meeting at 3:50 p.m. Motion carried.

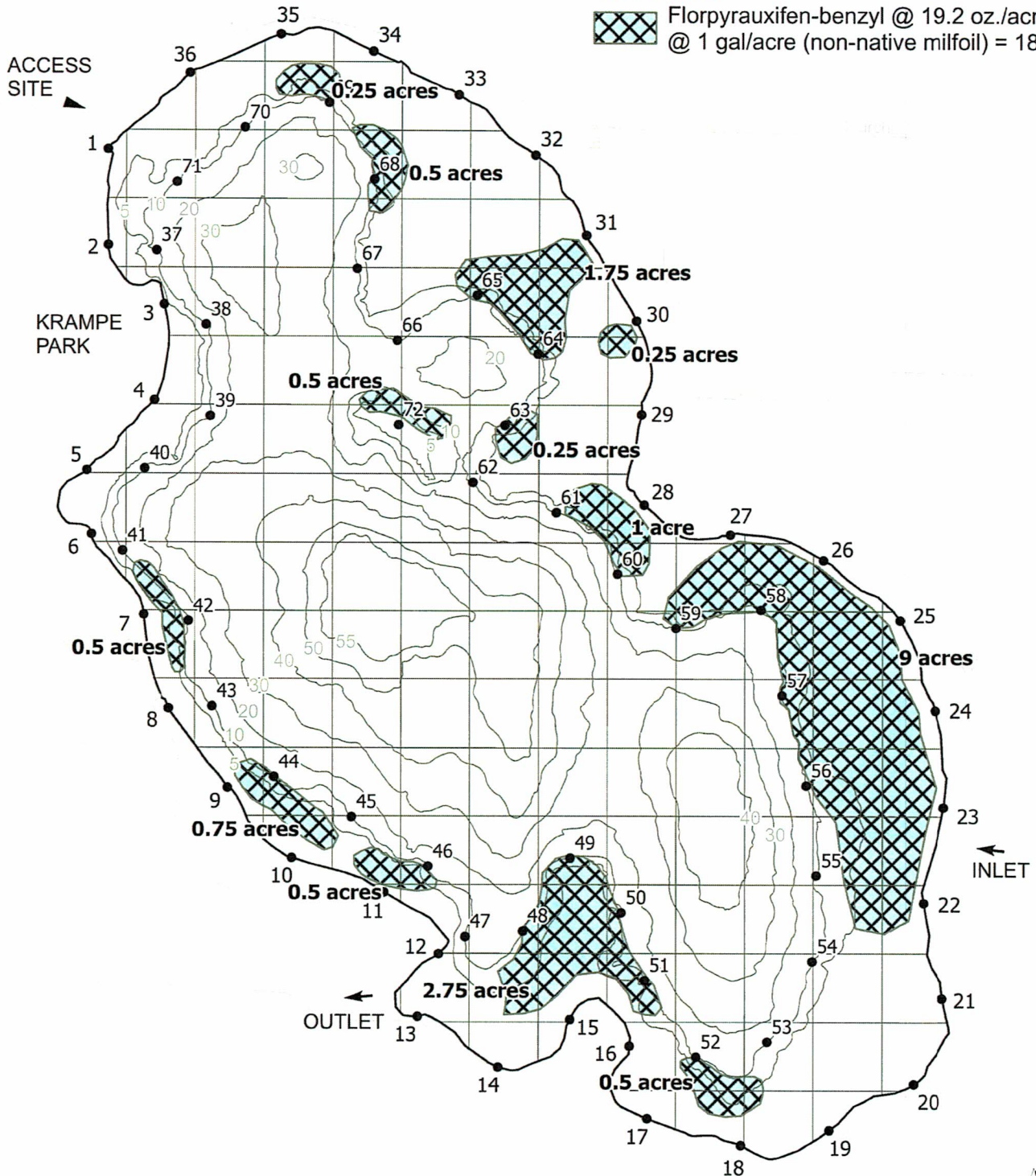


# WINFIELD LAKE MONTCALM COUNTY, MICHIGAN TREATMENT MAP SURVEY DATE: MAY 20, 2024

 = 1 ACRE

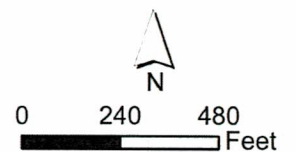

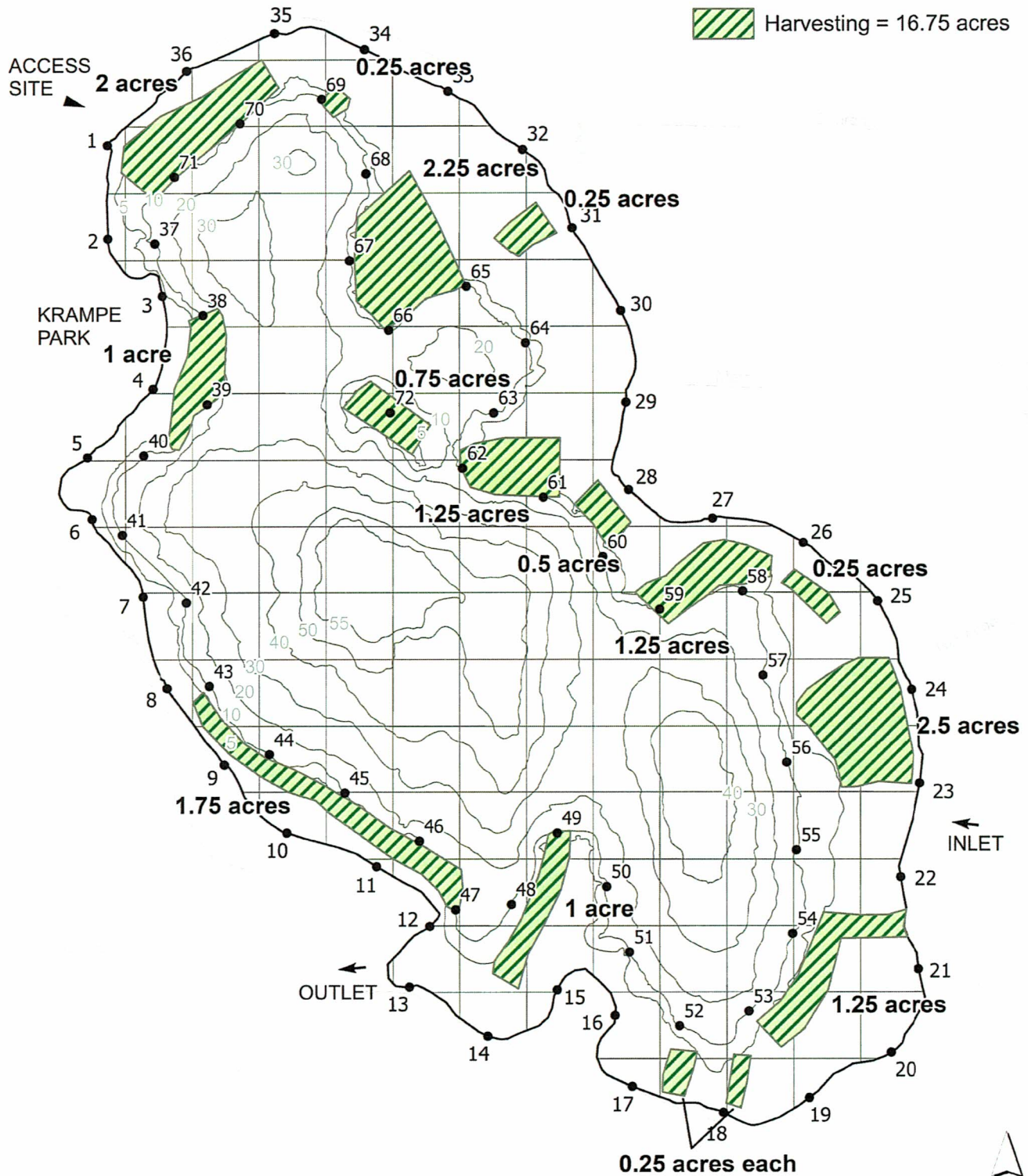


**WINFIELD LAKE

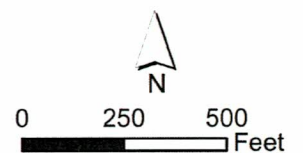

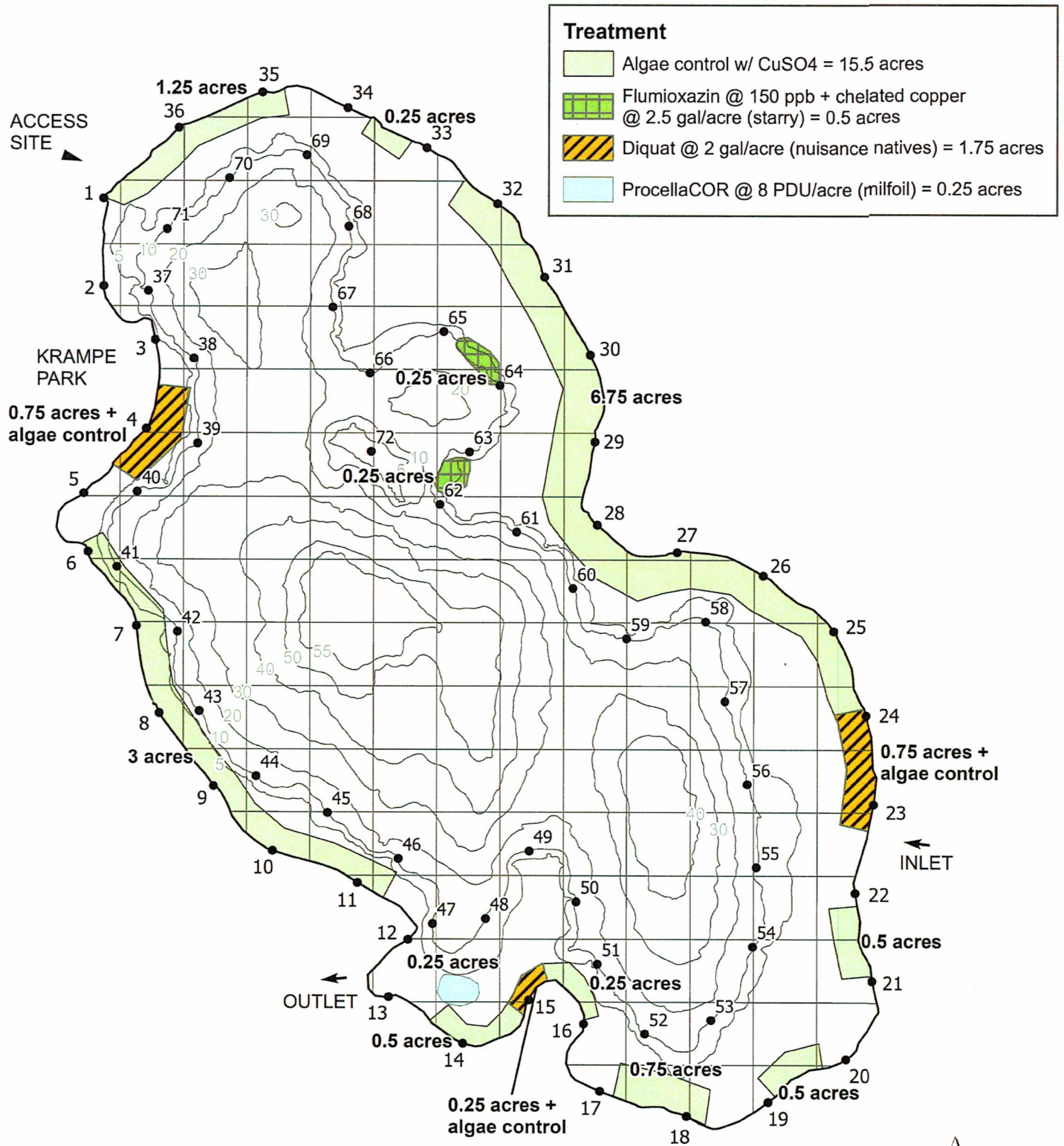

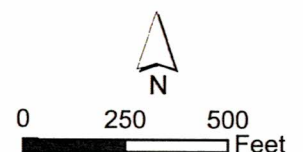
# WINFIELD LAKE MONTCALM COUNTY, MICHIGAN TREATMENT MAP SURVEY DATE: JULY 23, 2024

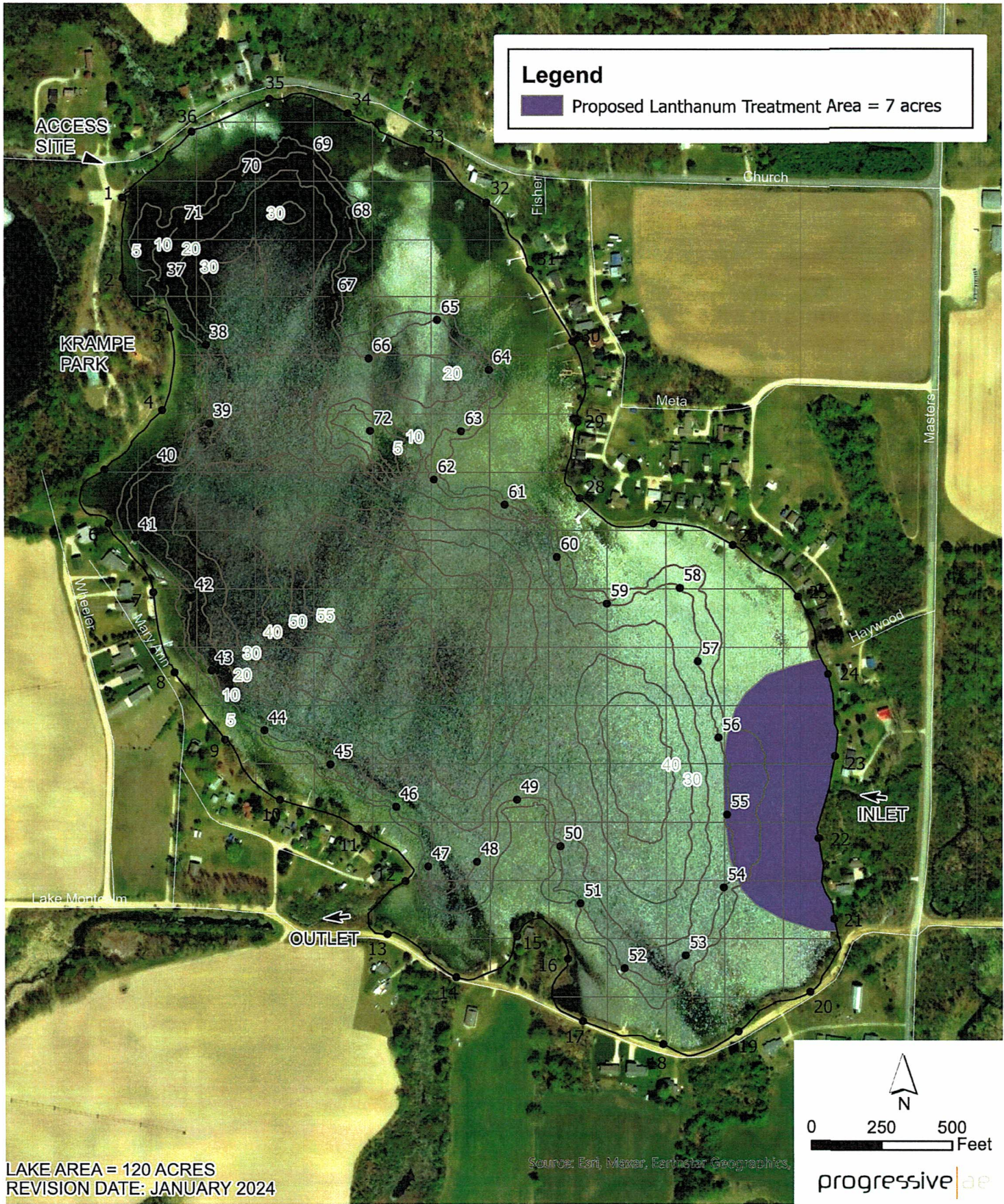

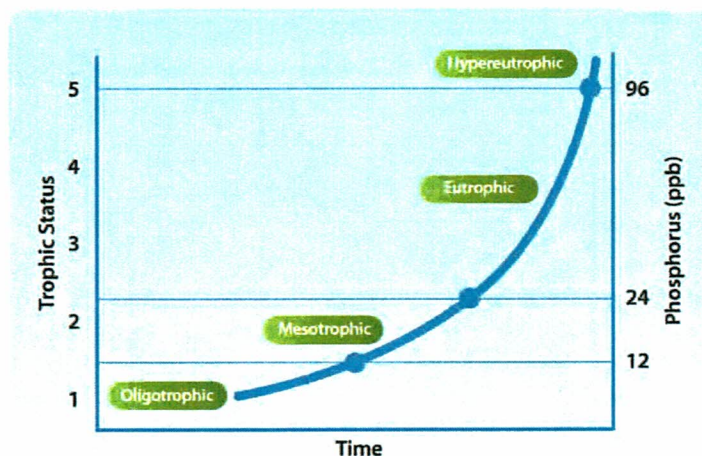

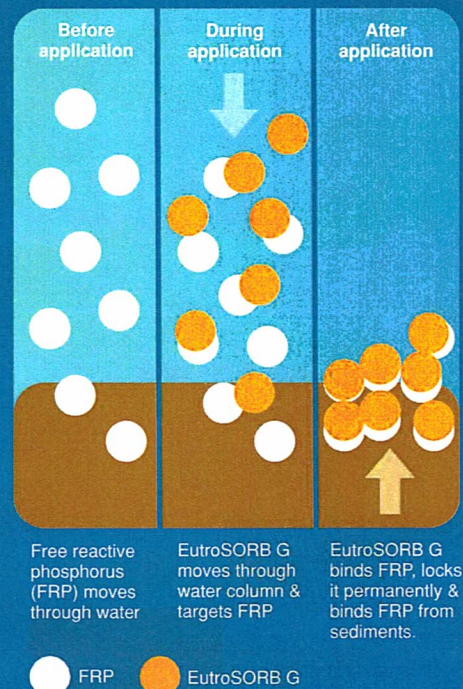
