ONE AND A FOURTH MILLS (1.25) FOR TOWNSHIP POLICE DEPARTMENT**

Shall Home Township impose an increase of up to 1.25 mills (\$1.25 per \$1,000 of taxable value) in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution and levy it for 5 years, 2025 through 2029 inclusive, for funds for police department operation, vehicles, apparatus, equipment and housing; in Home Township, which 1.25 mill increase will raise an estimated \$97,245.46 in the first year the millage is levied.
