## **DOG LICENSE APPLICATION**

STATE LAW REQUIRES ALL DOGS FOUR (4) MONTHS OF AGE AND OLDER TO HAVE A CURRENT RABIES VACCINATION AND LICENSE AT ALL TIMES. DELINQUENT FEES ARE DUE ON ALL LICENSES THAT ARE NOT LICENSED WITHIN THAT MONTH.

ALL DOG LICENSES EXPIRE ON THE LAST DAY OF THE MONTH IN WHICH THE RABIES VACCINATION EXPIRES.
